On 01-29-2021, victim stated that at approximately 2200 hours, he was approached by known subjects Treyh and Tyhre Webster, occupied by Tyhre Websters blue 2020 model Nissan Altima. It is stated that Tyhre displayed a handgun and told him to drop the charges against him in reference to a pending robbery case in which is the victim of, and Treyh was arrested. It is stated that Treyh began following him in the Nissan Altima driven by Tyhre. While being followed. Tyhre attempted to ram vehicle. It is stated that while being followed Treyh fired several shots at him before he was able to lose him in the area of Dawes Rd.

Treyh also used a black handgun to rob for this property in the prior robbery case that is pending.

In a prior incident involving Treyh Webster and other relatives, an AR-15 rifle was recovered when one of Websters relatives was shot, nobody took responsibility for the rifle.

On 02-02-2021 Treyh Webster called the witness in reference to this intimidating witness incident and threatened to kill him before Treyh goes back to jail.

The residents of the aforementioned property pose a high threat to law enforcement due to a history of being armed with firearms and threatening to harm/kill individuals with firearms. Treyh Webster

is currently on bond for Robbery 1<sup>st</sup> Degree and likely knows that his actions will result in another arrest. It is unknown how many other subjects (adults and juveniles) reside at the residence due to the amount of vehicles seen parked at the residence aside from Treyh and Thyre Webster, and their mother Georgette Sons.

Treyh and Thyre Webster both reside at their mothers address located at 7200 Lakeview Dr E. as and the Nissan Altima that Thyre Webster was driving is registered at that address. Thyre Webster has a criminal history of shooting into occupied vehicles and it is probable that he and Treyh both store firearms at their place of residence.

Based upon the aforementioned facts and information, I respectfully request that an anytime Search Warrant be granted for the location mentioned in Section One of the Affidavit.
