MESSAGE FROM THE CHIEF OF POLICE



City of Mobile has certainly seen its share with a record number of 51 criminal homicides for the year. The city was down overall 6.6% in Part I Crimes. The marked reduction was attributed to the prevention of mostly property crimes such as larceny and burglary cases. Although we gained significantly in the reduction of crime in those areas, we found ourselves up more than 18% in violent crimes.

It was apparent that violent crime trended up nationwide in 2021. The

2021 was a remarkable year as it relates to the uptick in violent crime. The selection of a new police chief, appointment of a new assistant

chief, and promotions of half the executive staff coupled with record

attrition numbers made for challenging times regarding our fundamental duties as a police organization, which is primarily prevention, intervention and enforcement.

We have much work to do in reducing our violent crime rate. Getting back to the basics of intelligenceled policing, while leveraging our efforts with cyber technology and our federal partners with the prosecution of recidivists' offenders, will certainly aid us in our efforts. Aniah's Law, pending in the Alabama State Legislation, if ratified will in effect amend the Alabama Constitution and give our judges the ability revoke or deny bonds for those charged with certain violent crimes, or the likelihood of those individuals to reoffend. Keeping that criminal element off the street will certainly have that desired effect of reducing crime in our neighborhoods.

With the implementation of intelligence-led policing, outlined in the 2021 Operations Strategy, along with our efforts in implementing new technology and strategies such as Operation Echo Stop, the Mobile Police Department will be effective in reducing all Part I Crimes. I look forward to serving the citizens of Mobile and together we can create a quality of life that is one of peace and tranquility. But I cannot overstate the need for community engagement and involvement with the police department. Together we are One Mobile.

For 2021, the Mobile Police Department was budgeted for 491 sworn officers and 212 civilian employees.

GRANTS AWARDED

For the 2021 fiscal year, the Mobile Police Department was awarded \$7.5 million in grant funding for 24 separate grant programs and awards. Most of the grants allocations are used to purchase equipment and fund overtime pay for officers, although other grant programs were specifically awarded.

The 2021 grant fiscal year is October 1, 2020 to September 30, 2021.




























PRECINCT 1 CRIME DATA

Overall, Precinct 1 had a 6.1% decrease in Part I Crimes.


PRECINCT 2 CRIME DATA

Overall, Precinct 2 had a 5.9% decrease in Part I Crimes.


PRECINCT 3 CRIME DATA

Overall, Precinct 3 had a 9.7% decrease in Part I Crimes.


PRECINCT 4 CRIME DATA

CENTRAL PRECINCT CRIME DATA





HOMICIDE DATA

86.27% Clearance Rate

For 2021, the Mobile Police Department's homicide clearance rate is 86.27%. There were a total of 51 homicide cases with 44 of those being cleared.



The motive for 12 or (23%) of the homicides was due to an altercation. Domestic (6), robbery (5) and drugs (4) were other motives. The motive is unknown for 22 of the homicides.



Two homicides fall into the other category. One was a situation where the wrong person was shot and not the intended target. The other case involved a burglary.

INTERNAL AFFAIRS INVESTIGATIONS

The Internal Affairs Unit conducted a total of 28 investigations involving a total of 37 members/employees. The investigations included two shooting investigations. The dispositions are represented in the following table.

An Internal Affairs investigation may include more than one member/employee with differing dispositions for each employee.

INTERNAL AFFAIRS INVESTIGATIONS

Citizen Complaints

There were 100 citizen complaints filed during 2021, which cited 225 areas of concern. Of the 225 areas of concern cited, 61% were unfounded, 17% were found to contain proper conduct by the officers, 19% were found to contain improper conduct, 1% was found to be policy failures, 1% had insufficient evidence, and 1% was withdrawn by the complainant.
